PRIVACY POLICY AND MINORS

This service does not allow the entry to persons under 13 years, except when under that age, they enter with the knowledge, consent and control of their parents or guardians. 5. We do not share personal information with third parties from their children unless those third parties are a fundamental part of running HEAVEN & EARTH (Example: company servers or IT security company).
6. We adopt security measures to safeguard personal information from children, during collection, communication, treatment and disposal of data,

including encryption policies to ensure confidentiality and security.

7. Once completed the object of the collection, maintenance and processing of personal data from one holder, we will proceed to its destruction.

8. It is included within the meaning of “*Personal Information*” for the purpose of extending the coverage of this policy, data related to 1) geolocation, 2) images, photos and videos, 3) audio, and 4) persistent identifiers performing that track the activity of users across your Internet browsing or Apps.
